**1. SAFETY**

- WARNING!** Disconnect from the air supply before changing accessories or servicing.
- WARNING!** Due to the possible presence of asbestos dust from brake linings, when working around vehicle brake systems we recommend you wear suitable respiratory protection.
- WARNING!** Check correct air pressure is maintained and not exceeded. We recommend 90psi.
- DO NOT** use the wrench for a task it is not designed to perform.
- DO NOT** use worn, or damaged sockets
- DO NOT** use the wrench unless you have been instructed in its use by a qualified person.
- DO NOT** use the wrench for a task it is not designed to perform.
- DO NOT** carry the wrench by the air hose.
- DO NOT** operate the wrench if you are tired or under the influence of alcohol, drugs or intoxicating medication.
- DO NOT** carry the wrench with your hand on the power trigger in order to avoid unintentional starting.
- DO NOT** direct air from the air hose at yourself or others.
- Maintain the wrench in good condition and replace any damaged or worn parts. *Use genuine parts only. Unauthorised parts may be dangerous and will invalidate the warranty.*
- Keep air hose away from heat, oil and sharp edges. Check air hose for wear before each use and ensure that all connections are secure.
- Only use impact sockets which are specifically designed for use with an impact wrench.
- Wear approved safety eye/face shield, ear defenders, dust mask and hand protection.
- Follow all workshop safety rules, regulations, and conditions when using the wrench.
- Maintain correct balance and footing. Ensure the floor is not slippery and wear non-slip shoes.
- Operate with both hands when practical to do so.
- Keep children and non essential persons away from the working area.
- When not in use disconnect from air supply and store in a safe, dry, childproof location.

**2. INTRODUCTION**

Lightweight composite casing with two extruding edge strips to help protect housing. Specially designed motor gives high torques whilst working on low air consumption. One hand operation with three speed selector switch and forward/reverse control at your fingertips. Handle features a downward facing exhaust to lower noise level and soft grips to help reduce vibration and chill. Suitable for professional garages.

## 4. PREPARATION

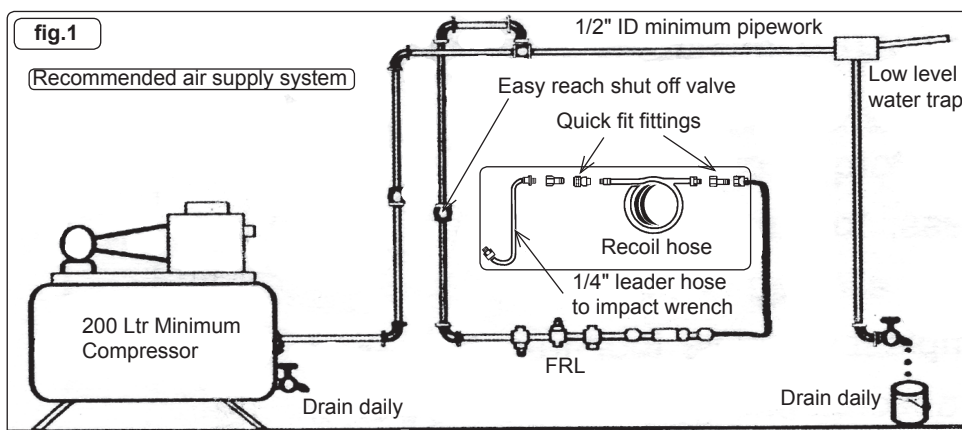
- ❑ **WARNING!** Ensure the air supply is clean and does not exceed 90psi while operating the wrench. Too high an air pressure and/or unclean air will shorten the product life due to excessive wear, and may be dangerous causing damage and/or personal injury.

### 4.1. AIR SUPPLY

- 4.1.1. Ensure the wrench trigger is not depressed when connecting to the air supply.
- 4.1.2. You will require an air pressure of 90psi, and an air flow according to specification.
- 4.1.3. Drain your compressor air tank of water daily. Water in the air line will damage the wrench.
- 4.1.4. Clean the compressor air inlet filter weekly. Recommended hook-up procedure is shown in fig.1; see also note 4.2.
- 4.1.5. Line pressure should be increased to compensate for unusually long recoil air hoses (over 8 metres). The minimum supply pipework should be 1/2" I.D. **NOTE!** the impact wrench requires a 1/4" BSP fitting.
- 4.1.6. Keep hose away from heat, oil and sharp edges. Check hose for wear, and make certain that all connections are secure.

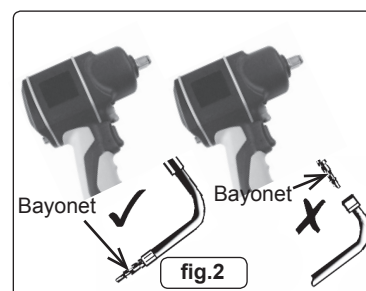
### 4.2. COUPLINGS

Vibration may cause failure if a quick change coupling is connected directly to the wrench. To overcome this, connect a leader hose to the wrench. A quick change coupling may then be used to connect the leader hose to the air line recoil hose. See fig.1 & fig.2.



## 5. OPERATION

- ❑ **WARNING! Ensure you read, understand and apply safety instructions before use.**
  - 5.1. Only use impact sockets which are specifically designed for use with an impact wrench.
  - 5.2. Connect the wrench to the air hose as in section 4.
  - 5.3. Place the socket fully over the subject nut and depress the trigger to operate the wrench.
  - 5.4. To change direction, depress the plunger on the rear of the body for direction "F" or above the trigger for direction "R". (fig.3)
  - 5.5. The three torque settings, represented by ascending size detents are changed using the knob sited above the trigger.
- X **DO NOT** use any additional force upon the wrench in order to remove a nut.  
 X **DO NOT** allow the wrench to free run for an extended period of time as this will reduce bearing life.



## 6. MAINTENANCE

- ❑ **WARNING!** Disconnect the wrench from the air supply before changing accessories, servicing or performing maintenance. Replace or repair damaged parts. *Use genuine parts only. Unauthorised parts may be dangerous and will invalidate the warranty.*
- 6.1. If the air system does not have an oiler, lubricate the air wrench daily with a few drops of Sealey air tool oil dripped into the air inlet (fig.4).
- 6.2. Check and top up the gearbox by removing the socket set screw located beneath the impact head.
- 6.3. Clean the wrench after use with a mild detergent on a moist cloth.
- 6.4. For a full service contact your local Sealey service agent.
- 6.5. When not in use, disconnect from the air supply, store in a safe, dry, childproof location.

## 7. TROUBLESHOOTING

- 7.1. Loss of power or erratic action may be due to the following:
  - a) Excessive drain on the air line. Moisture or restriction in the air pipe. Incorrect size or type of hose connectors. To remedy check the air supply and follow instructions in section 4.
  - b) Grit or gum deposits in the wrench may also reduce performance. This may be evident in the air strainer located in the area of the air inlet (fig.4). Flush the wrench out with gum solvent oil or an equal mixture of SAE No 10 oil and paraffin. Allow to dry before use.

## WARNING! – Risk of Hand Arm Vibration Injury.

**This tool may cause Hand Arm Vibration Syndrome if its use is not managed adequately.**

This tool is subject to the vibration testing section of the Machinery Directive 2006/42/EC.  
This tool is to be operated in accordance with these instructions.

**Measured vibration emission value (a): . . . . . 9.44 m/s<sup>2</sup>**

**Uncertainty value (k): . . . . . 1.5 m/s<sup>2</sup>**

*Please note that the application of the tool to a sole specialist task may produce a different average vibration emission. We recommend that a specific evaluation of the vibration emission is conducted prior to commencing with a specialist task.*

A health and safety assessment by the user (or employer) will need to be carried out to determine the suitable duration of use for each tool.

**NB:** Stated Vibration Emission values are type-test values and are intended to be typical.

Whilst in use, the actual value will vary considerably from and depend on many factors.

Such factors include; the operator, the task and the inserted tool or consumable.

**NB:** ensure that the length of leader hoses is sufficient to allow unrestricted use, as this also helps to reduce vibration.

*The state of maintenance of the tool itself is also an important factor, a poorly maintained tool will also increase the risk of Hand Arm Vibration Syndrome.*

### Health surveillance.

We recommend a programme of health surveillance to detect early symptoms of vibration injury so that management procedures can be modified accordingly.

### Personal protective equipment.

We are not aware of any personal protective equipment (PPE) that provides protection against vibration injury that may result from the uncontrolled use of this tool. We recommend a sufficient supply of clothing (including gloves) to enable the operator to remain warm and dry and maintain good blood circulation in fingers etc. Please note that the most effective protection is prevention, please refer to the Correct Use and Maintenance section in these instructions.
