- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

## **SUPPLIER ADHERENCE TO OUR VALUES**

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we have supplier agreements and requirements for declarations policies. Our compliance is achieved through the Integrated Management System including **ISO14001** and the use of a Compliance Register which is regularly reviewed and audited.

## **TRAINING**

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide awareness briefings to our staff.
