DESCRIPTION

Kresto® Kolor ULTRA is a solvent-free and preservative-free special hand cleanser for removing contamination caused by dyestuffs.

AREA OF APPLICATION

For removing dyestuffs which are reducible within the alkaline range, such as toner, aniline dyes, azo dyes, printing and copying inks, fruit and vegetable colourants.

PRODUCT DESCRIPTION

Beige, perfumed paste-like suspension.

INSTRUCTIONS FOR USE

- Do not wet soiled hands.
- Rub in Kresto® Kolor ULTRA thoroughly.
- Add a little water and wash until most of the colourant contamination has been removed.
- Thoroughly rinse off.
- Dry carefully.

Repeat process after drying hands if necessary. The slightly sulphurous odour of Kresto® Kolor ULTRA emanates from the reducing agent.
