#### **DIRECTIONS FOR USE**

#### **PREPARATION**

- The surfaces to which the adhesive is to be applied must be clean and dry.
- Always open and use adhesives over protected work surfaces.
- 3. Remove the cap and turn the tube base to slightly extend the glue stick.

#### **APPLICATION**

- 4. Apply the glue with firm even strokes.
- 5. Wind Bostik Blu Stick back into dispenser.
- Remove excess glue from body of stick with a clean tissue.
- 7. Replace the cap after use.

#### CLEANING

- 8. Excess adhesive may be removed with a damp cloth
- Adhesive on clothing may be removed with water before the adhesive dries.
