ELECTRIC VEHICLE CHARGER - WARRANTY



UK, CHANNEL ISLANDS & REPUBLIC OF IRELAND

Your EO Charging electric vehicle charger has the benefit of our manufacturer's warranty, which covers the cost of breakdown repairs for one* year from the date of purchase. This gives you the reassurance that if, within that time, your charger is proven to be defective because of either workmanship or material defect we will, at our discretion, either repair or replace the charger at no cost to you.

This warranty is subject to the following conditions:

- The charger has been installed by an EO approved installer and operated correctly
- The charger is used only on the electricity supply printed on the rating plate
- The charger has been used only to charge an electric vehicle
- The charging cable has been replaced in the holding socket when not in use (applies only to tethered units not socketed units)
- The charger has not been altered, serviced, maintained, dismantled or otherwise interfered with by any person not authorised by us. For the avoidance of doubt any attempt to open the unit by anyone other than ourselves or our appointed agent will invalidate the warranty
- Any repair work must be undertaken by us or our appointed agent
- Any parts removed during repair work or any charger that is replaced become our property
- The charger is used in the United Kingdom or Republic of Ireland

The warranty does not cover:

- Damage resulting from transportation, improper use, wear and tear, neglect or interference or as a result of improper installation
- Replacement of any consumable item or accessory not supplied by us.

2 Year Return to Base Warranty *

For years 2 and 3 of your ownership of one of our electric vehicle chargers, EO Charging also offers you a free 2 years return to base warranty. 'Return to base' means you will be responsible for covering the costs associated with sending out an engineer (approx. £80 per visit) to remove the existing charger and replace it with a new one and the cost of posting the replaced unit back to EO (approx. £30). This additional warranty is conditional on you registering your EO charger with us and the new unit being fitted by one of our authorised agents. EXTENDED WARRANTY *

We also offer an extended warranty for up to a further 4 years from the end of the first year, providing full parts and labour warranty (in place of the return to base warranty for years 2 & 3). The extended warranty is available at a cost of £50 per annum. For further information simply call our registration line on +44 (0) 333 77 20 383

* If your electric vehicle charger has been installed under the OLEV Electric Vehicle Homecharge Scheme (EVHS) or Workplace Charging Scheme (WCS) then it has the benefit of THREE years' full parts and labour warranty with the option to purchase an extended warranty for years 4 & 5.
