4.1. Description of first aid measures

Skin contact: Remove contaminated clothing. Wash skin thoroughly with soap and water or use a proprietary skin cleaner. Do NOT use solvents or thinners. If irritation persists seek medical attention.

4.3. Indication of any immediate medical attention and special treatment needed

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide (CO₂). Dry chemical powder. Alcohol resistant foam. Sand or earth. Do NOT use water jet.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In a fire, hazardous decomposition products such as smoke and Carbon Monoxide may be produced.

5.3. Advice for fire-fighters

Advice for fire-fighters: Exposure to decomposition products may be a hazard to health. Appropriate self-contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do NOT allow run-off from fire fighting to enter drains or water courses.

6.1. Personal precautions, protective equipment and emergency procedures

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. Keep away from direct sunlight. Exclude sources of heat, sparks and open flame. Although the storage of this product is not subject to specific statutory requirements, the principles contained in the HSE guidance note Storage of Flammable Liquids in containers, should be observed.
